IMPORTANT NOTES

- 1. A BFG Form NOVA/NOVA NMT is required in order to register your vehicle for use in the United Kingdom.**
- 2. A BFG Form NOVA NMT will not normally be valid for use in relation to a tax-free vehicle if the Head of Family is not moving to the UK on permanent transfer of residence.**
- 3. A BFG Form NOVA/NOVA NMT MUST be issued prior to completion of the UK Registration process.**
- 4. The BFG F NOVA/NOVA NMT will only be valid for a maximum of 28 days. Registration must be completed between these dates.**

APPLICANT'S DECLARATION

I HEREBY DECLARE THAT:

- 1. I have read the important notes above. For NMTs: I understand and agree that I will retain possession of my vehicle until at least 365 days have passed after the date of initial BFG registration. I understand that should I dispose of a NMT prior to this, I will have waived my right to tax relief on this vehicle and I may also be sanctioned for future tax-free purchases.**

- The validity date of the BFG NOVA can be the same as the date of UK registration.
- You can only UK register your vehicle in BFG during a normal working day i.e. not weekends or stand-down days.
- If the vehicle requires a MOT this must be completed in the UK within 14 days of UK registration.

- 3. I, will ensure that the vehicle is returned to the UK.**
- 4. This is not a retrospective application. I am currently on the posted strength of BFG and am entitled in accordance with SO BFG 3213.**
- 5. I authorise C&I BFG to provide HMR&C with the NOVA information required on my behalf.**
- 6. This is to certify that I have physically checked the chassis number showing on the vehicle against the car registration documentation (BFG Form 73A) and the chassis number shown overleaf. I confirm that all chassis numbers are the same.**
- 7. I agree that, if the chassis numbers do not match and my original BFG NOVA has to be cancelled, I will pay a €20 re-issue fee prior to my receiving a new BFG NOVA.**
