Notes on completion

1. Complete Parts 1 and 2 using the notes on Page 4.
2. Carefully read and sign the declaration at Part 3.
3. Return the completed form to the BFG Vehicle Licensing Office enclosing your Unit details and Contact Number.
4. If you are disposing of your BFG registered vehicle you will need to deregister it using BFG Form 4003. If you are disposing of your vehicle to a non-entitled person you will also need either BFG Form 38 or BFG Form NOVA. Consult your Local BFG office for more information.
5. All entries must be completed in ink.

5. Roadworthiness Inspection Report - BFG Form 65 or a certified BFG Form 73 or MOT/TüV certificate (if the vehicle is over 3 years old).
